Wealth Mastery Educational Services Terms and Conditions v 4.00

Definition

- Wealth Mastery Pty. Ltd. ("WEALTH MASTERY") is the designated business providing the training courses, services and selling tickets for the events. Business Freedom Lifestyle is the designated business providing licensed intellectual property, books, diagrams and forms for the training.
- References to "we" or "us" in this Terms and Conditions are references to Wealth Mastery and / or Business Freedom Lifestyle Pty Ltd.
- References to "Client" or "Clients" or "You" in this Terms and Conditions are references to you the client and attendee.

Engagement

 You hereby acknowledge and agree that you have read all the terms and conditions contained in this form and you agree that these Terms and Conditions form a contract between you and Wealth Mastery.

Investment and Payment

- You must pay in consideration of the event ticket offered by Wealth Mastery in full sum on the signing of the registration form by you without set off, deduction or counterclaim unless otherwise agreed;
- Payments made under this agreement must be made by the means specified in the Registration Form. Payment options include Visa / Mastercard and direct deposit.
- All payments must be completed 30 days prior training commencement.
- 8. Your FULL PAYMENT entitles you to enter into an agreement directly with us to receive the Wealth Mastery products and/or services.

Cooling Off Period

- 9. This agreement shall be voided if you advise us in writing, within fourteen (14) calendar days of signing the Registration Form, that you no longer wish to receive Wealth Mastery services and/or product. You may send a cancellation notice via electronic mail to Wealth Mastery at askkel@keldavis.com.
- We will refund to you the amount or part thereof which you have paid under this agreement within thirty (30) business days of receipt of such cancellation notice.

Administrative Fee

- 11. Administrative fee/bank processing fee is applicable for any payment schedule changes, ticket transfers, or reenrollment as defined in sections 12, 13 & 14.
 - Administrative processing fee is \$75 AUD inclusive of GST.

Reenrollment

12. Any event purchase that is rescheduled from the original date must be rescheduled within the 12 months period of the original purchase, if not done fees will be forfeited. Rescheduling (reenrollment) within 30 days of the event will incur the booked seating, facilities & catering costs of \$200 (incl. GST) per day, payable at the time of rescheduling plus a \$75 (incl. GST) administrative processing fee.

Transferring Tickets

13. In the unlikely event that you are unable to attend the event you have booked and paid for, you can transfer your ticket to a nominated new attendee subject to written notification to us, together with the full contact details (email address, full name and telephone number) of your nominated new attendee. This notification must be at least 30 working days before the event starts. The administrative processing fee / material reprinting fee of \$75 AUD (incl. GST) applies to all transfers.

Cancellation Policy

- 14. Any cancellation requests must be made in writing and received before training commencement and will be assessed with the following charges:
 - 120 46 days prior to training commencement * 20% of the attendee's fees
 - 45 31 days prior to training commencement * 50% of the attendee's fees
 - 30 days or less before training commencement * 100% of the attendee's fees

Venue Time and Place

15. You confirm that you have provided us with a valid email address and contact phone number in the Registration Form. We will not be

- responsible and/or liable for any delay and/or failure to deliver products and/or services to you resulting from your failure to supply a valid email address.
- 16. In the unlikely event that the venue or dates are changed for any reason, we will notify you in writing (email, text or SMS). You retain the right to reschedule your enrolment within the 12-month period (without rescheduling fees) in accordance with the Re-enrolment section 12, you will have no additional claim against us for compensation or refund.
- 17. You agree that we reserve the right to amend or cancel any event time, dates, and venue and/or substitute the guest speakers or event speaker for any live training. We will notify you in writing of the changes made before the event and:
 - you are not entitled to claim for a refund or for any costs, expenses, losses, damages or liabilities which may be incurred or suffered by you as a result of such cancellation/amendment/changes
 - b. you retain the right to reschedule, subject to the availability of an alternative session.
- 18. You agree that we reserve the right to modify the schedule, substitute the guest speakers, event speaker, simulation or activities, timing, schedule or activity length during any live training event with verbal notification.

Refunds

- 19. We may cancel the products/services for any reason whatsoever by written notice to you. You acknowledge and agree that in the event the products/services are cancelled by Wealth Mastery, you are only entitled to a refund of the Investment which you have paid to us and that you shall not claim for any other costs, expenses, losses, damages or liabilities which may be incurred or suffered by you as a result of such cancellation.
- 20. You further acknowledge and agree that any refunds payable to you shall be paid to you by us and will be made within thirty (30) days of written notice of cancellation. You shall have no further claims against us in respect of the cancellation thereafter.
- 21. You acknowledge that you shall not be entitled to and shall not claim a refund other than by strict compliance with Clauses 22, 32 and 33 hereof. You further acknowledge that this is an essential term of this agreement which we relay to you.

Participation

- You acknowledge that the training course and speakers require you
 to actively participate in the study, homework, break activities,,
 exercises and simulations. In the event that you as the attendee, fail
 to complete the homework, activities, exercises, participate in the
 training to the satisfaction of the speaker, or wealth mastery event
 organizers the following conditions applies;
 - You will be coached once verbally about the participation obligation and active involvement by a Wealth Mastery representative
 - At the next failure to participate, you will be asked to leave the training room without further discussion or communication

Minors

- 23. The Wealth Mastery training course is designed using adult learning techniques requiring full attention without any distractions. To achieve this level of consciousness, the minimum age of participation in the course is 18 years old.
- 24. In the event that a minor between the ages 15 17 are interested to attend the course, they will be permitted provided that they are under direct supervision of their parent or guardian and their participation is approved by the Events Coordinator.
- Minors and children under the age of 15 years old are not permitted to be present in the training room.
- 26. Wealth Mastery and the training venue does not take responsibility for any minors before, during and after the training the courses.

Limitation of Liability

27. We:

- exclude all terms, conditions and warranties implied by custom, the general law or statute, or which cause any part of this agreement to be void ('Non-excludable condition').
- limit our liability to you for breach of an Non-excludable Condition to the total amount actually paid by you under this agreement;
- c. limit our liability to you for any claim (whether arising in contract, tort or statue) for any loss or damage whatsoever suffered by you in relation to providing the opportunity to you to purchase the Wealth Mastery products and/or services to the total amount actually paid by you under this agreement;

Force Majeure

28. General

- 29. The laws of the state of Queensland govern this agreement. Should any part of this agreement be determined by a court to be invalid or unenforceable, the remainder of the agreement will be unaffected. This agreement may not be varied except with the written approval of a Director of Wealth Mastery Pty Ltd. All terms, conditions and warranties implied by the statute that are excludable are excluded from this agreement.
